5. The subscriptions payable by the Members of the Association shall be such sum or sums as shall from time to time be determined by a resolution at a General Meeting. The rates of subscriptions (subject to any subsequent revision as aforesaid) are follows: (a) Subscription for Ordinary Members is HK\$100.00 for 2 years which shall be due on 1 st day of (January) each calendar year. (b) Life Members will be exempted from paying the annual subscription after they have paid up a lump sum contribution as aforesaid. (c) Honorary Members are not required to pay any membership subscription. Members who are to be absent from Hong Kong for more than one financial year (years) need not pay any subscription for that financial year (years) and could be reinstated as members afterwards provided that they have given due notice to the Secretary before leaving Hong Kong.	5. The subscriptions payable by the Members of the Association shall be such sum or sums as shall from time to time be determined by a resolution at a General Meeting. The rates of subscriptions (subject to any subsequent revision as aforesaid) are follows: (a) Subscription for Ordinary Members is HK\$100.00 for 2 years.
